Catholics United for the Faith (CUF) reserves the right to reject and/or pull any and all material that does not adhere to the teachings of the Magisterium of the Catholic Church.

**Subleasing of tables is not allowed.**

The leasing of space to politically affiliated persons or groups is prohibited. Further, the distribution of materials and/or literature that fosters or is in opposition to political parties or candidates is prohibited.

CUF reserves the right to require the immediate withdrawal of any exhibit which CUF believe to be injurious to the purpose of CUF. **NO REFUND** will be given.

The sale of all types of merchandise and/or specific products at the conference is subject to approval by CUF. Selling food or beverages of any kind is prohibited.

Exhibitors must surrender their exhibit space in its original conditions. The exhibitor shall not injure or deface the walls or floors of the exhibit facilities, the tables and any other furniture. When such damage occurs the exhibitor shall be liable to the owners of the property damaged.

Exhibitors are responsible for the conduct of all individuals in connection with their exhibit and shall conduct themselves in an ethical and dignified manner at all times.
